Thank you for attaching the notice. With regard to the advertisement needing to be published no more than 21 days before the submission of the application, it is my understanding that according to The Town and Country Planning (Development Management Procedure) Order 2013, where the applicant has taken reasonable steps to ascertain the names and addresses of every such person (who on the prescribed date is an owner of the land to which the application relates, or a tenant) but has been unable to do so, by publication of the notice after the prescribed date in a newspaper circulating in the locality in which the land to which the application relates is situated. So I propose to complete notice 2 and make arrangements for it to be published in the Coventry Evening Telegraph. I would be grateful if you could confirm this is acceptable.

Having received your letter please see find our responses to your questions posed and request for additional information below;

- 1) The proposal and site address are acceptable to ourselves.
- 2) A document detailing the proposed heads of terms for the Section 106 Agreement is attached.
- 3) To clarify the Local Centre will have approximately 4000msq gross floor area – to allow for A1, A2, A3, A5 for retail and/or D1 uses (any single retail element will not exceed 2,500 msq total (GFA). The proposed primary school will be up to 2FE.
- 4) An Agricultural Holding Certificate will be sent in due course.
- 5) Please find attached an indicative phasing plan.
- 6) I can confirm the drawings that form part of the submission are illustrative, and are to be used for this purpose.
- 7) I ask that the issue of land contamination is dealt with, with reference to the information in the relevant ES chapter (Chapter 9). This will then allow for consideration of the land contamination ES chapter information by the relevant consultees and will allow for discussions on how best to address through the course of the consultation process.
