Thanks for the additional information Ahmed,  
Subject to you submitting correspondence from the agent/s who have been marketing the premises to demonstrate that no industrial user has been interested in the site for over a year and that the site has been marketed at a reasonable price, I consider the loss of this light industrial unit from the employment land supply to be acceptable. With regard to the proposed use, a short transport statement would be required to demonstrate that the proposal would not result in unacceptable competition for on street parking resulting in highway safety concerns  
Finally a sequential assessment of sites in and within 300m of Foleshill Road district centre and Hillfields local centre would be required to see if there are any vacant suitable premises in or around defined commercial areas. If vacant sites are identified but are not acceptable/suitable the reason would need to be stated.  
If these issues are resolved then I think the principle of the use would be acceptable subject to restrictions on hours of use
