The proposal is to install a modular garage of 6.2L X2.9W X2.6H at the rear of the Crematorium Lodge Building on the Canley Garden Cemetery and Crematorium Site.  
The garage is to be constructed of a prefabricated concrete panel garage with a 12.5 Degree pitched roof. The front elevation of the building will facilitate a roller shutter door and a personal access door (please refer to drawing for dimensions).  
The yard at the rear of The Lodge where the proposed modular garage is to be located currently facilitates a number of sheds and a modular building that acts as a mess area for members of the grounds staff. The proposed garage is to be located on an area of land between an existing modular building and a timber shed within this service yard. It will be located 1 metre away from the site boundary that is denoted by a 2 metre high timber fence.
