We are very open to alternatives and are not seeking a pastiche of the existing building, although a more traditional form should be considered even in a more contemporary design. I would suggest that the new extension is subordinate, if a flat roof is proposed to the higher level it should have a parapet detail, the roof lantern should be removed and the external stairs should be accommodated internally. Consideration needs to be given to the proximity of the rear windows in Gosford Books, many of which are understood to be habitable. The flue also needs to be carefully designed into a chimney, the current is unacceptable.

Elements of the current design appears to be similar to a National Trust café n nearby Warwickshire (pic attached) and could be a good basis to expand from.
